POSITION SUMMARY:

This job class requires knowledge of federal and state codes, laws and regulations regarding electrical and fire life safety installation, repair, and maintenance.

- 1. * Complies with National Electrical Code and company standards when wiring equipment, following all applicable safety policies and codes.
- 2. * Works standard computations relating to load requirements of wiring and electrical equipment.
- * Uses a variety of electrician's power and hand tools, measuring and testing instruments.
- 4. * Works from blueprints, drawings, layouts, or other specifications.
- 5. * Installs, maintains and operates electrical systems, equipment, and appliances, such as generators, transformers, switchboards, controllers, circuit breakers, motors, electric gate crossings, signals, switches, or other equipment.
